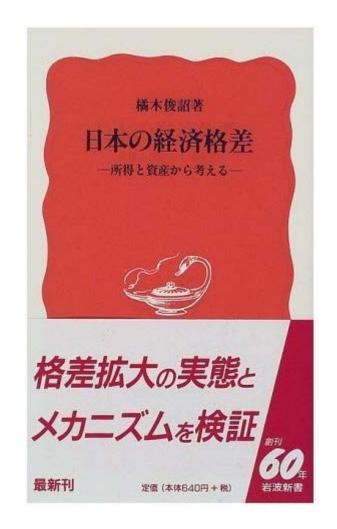

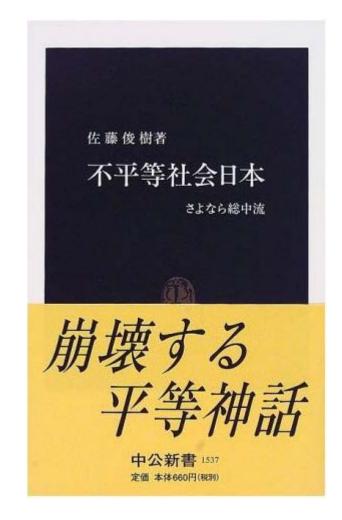
Increasing Inequality

- For long time, Japan has been considered to be an equal society.
- However, the long-run economic slump has raised the increasing inequality as a structural disease of Japan.
- The issue was originally addressed by Tachibanaki in 1998.



Occupations and Classes

- Sato (2000) focused on the occupation succession from fathers to sons.
- The author divides a variety of occupations into several social classes, and has found that:
- Sons are highly likely to remain in the same social class their fathers belong to.



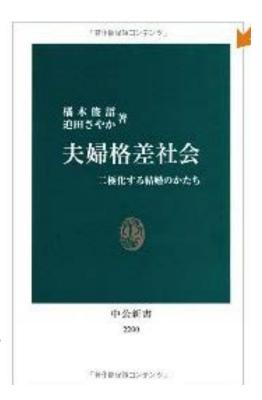
Aging and Inequality

- Ohtake (2005) argues that the increasing inequality in 1990s has been caused mainly by population aging.
- Inequality within a generation is small when the generation is young, while it is large as the generations gets old.
- Ohtake has concluded that
- Inequality in the same age group has not been increased in the last decade.
- 2. The increasing inequality at aggregate level is caused by the increasing old population.



Inequality across households

- Tachibanaki and Sakoda (2013) point out that inequality across households is larger than individual inequality.
- Inequality in individual income is amplified by marriage, if high-income male is matched with high-income female.
- In the current trend, retired people live separately from their sons and daughters.
- Marriage rate has been declining.
- Single-member households are often very poor.



Polarization of Jobs

- Autor et al (2006) argue that technological progress replaces routine, manual workers with computers.
- Computers are compliments to abstract, nonroutine, and non-manual works.
- The use of computers increases the productivity of the abstract, non-routine, and non-manual workers and raises their wages.

The trends in upper-half and lower-half inequality diverge after 1987

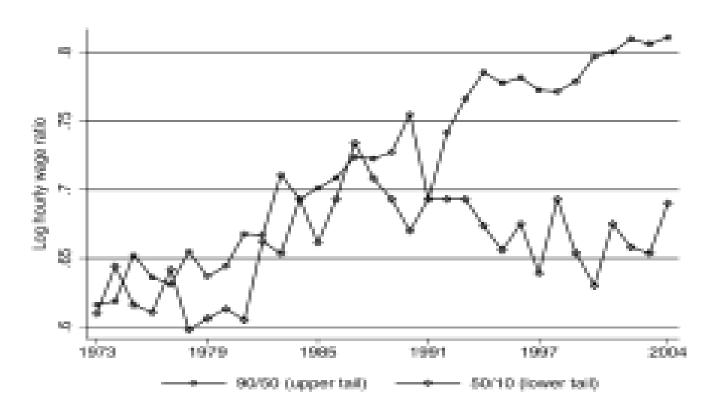


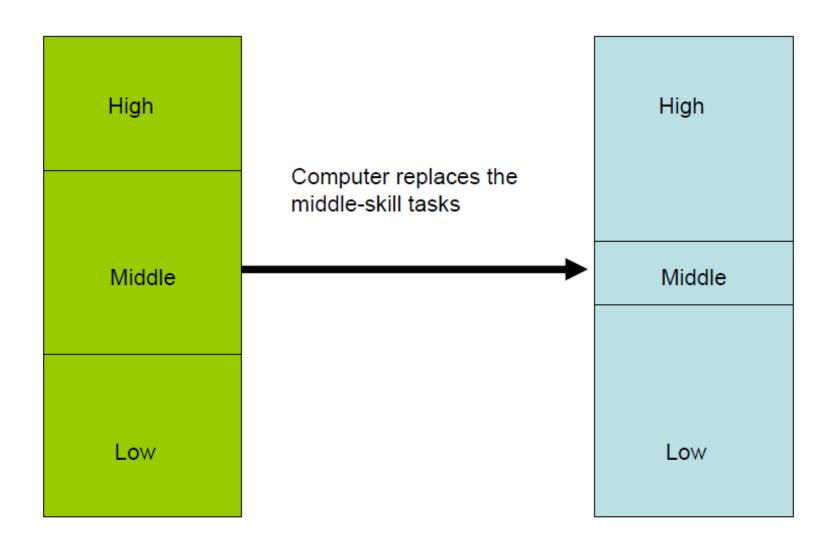
FIGURE 1. MALE AND FEMALE LOG HOURLY 90/50 AND 50/10 EARNINGS RATIOS

Type of tasks

- (A) Abstract, non-routine, non-manual tasks such as problem solving and coordination.
- (R) Routine, non-manual tasks such as clerical work and repetitive production tasks.
- (M) Non-routine, manual tasks such as truck drivers, waiters, janitors.

- Thomas Piketty (University of Paris) has recently published a controversial book to warn us of the increasing wealth inequality and its apocalyptic consequences.
- The author concludes that the wealth concentration to the top population will eventual result in social instability and revolutions.

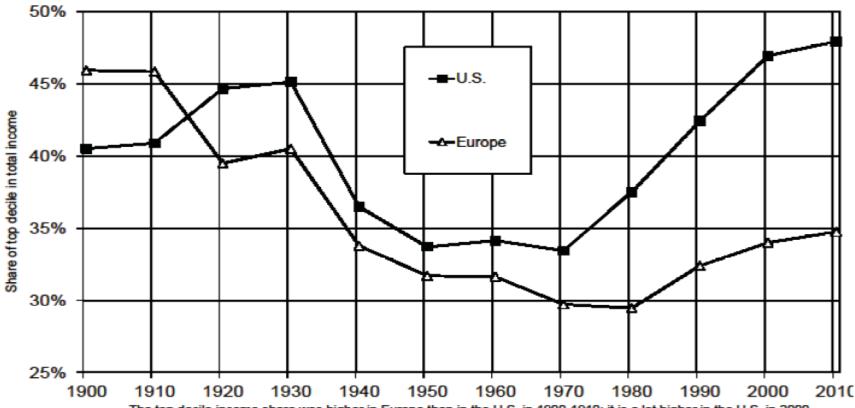
In Europe, capital/income ratio is growing and approaching its 19th century level

Figure 9.8. Income inequality: Europe vs. the United States, 1900-2010



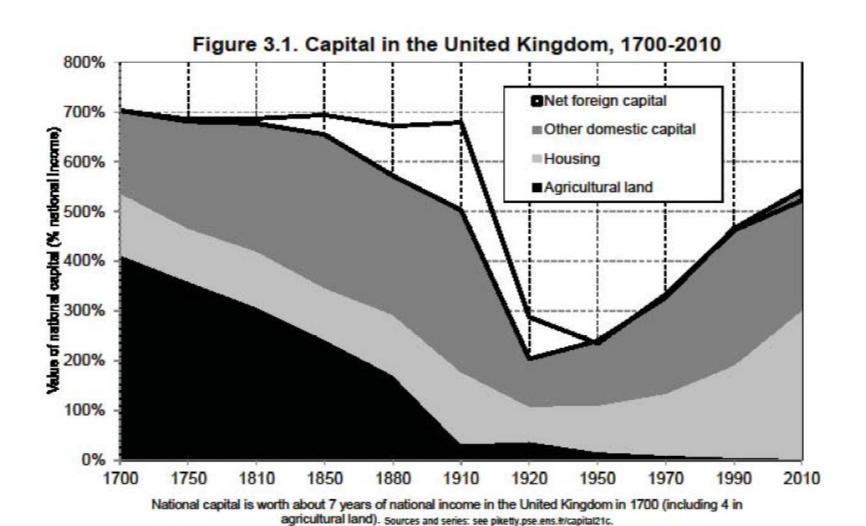

Private capital grows and public capital declines relative to GDP

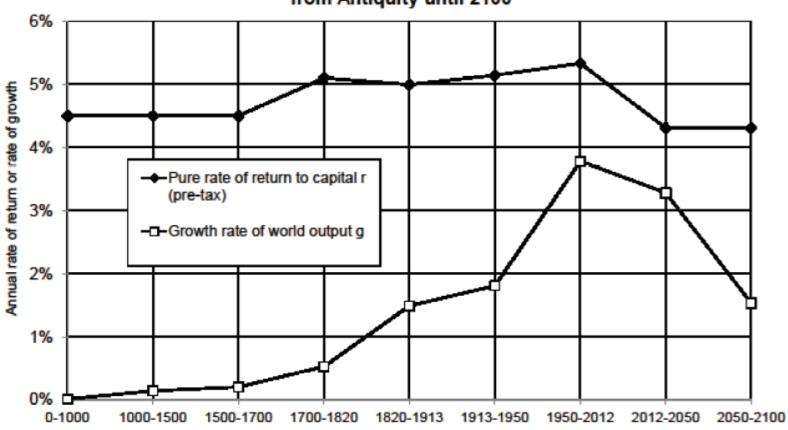

Figure 10.9. Rate of return vs. growth rate at the world level, from Antiquity until 2100

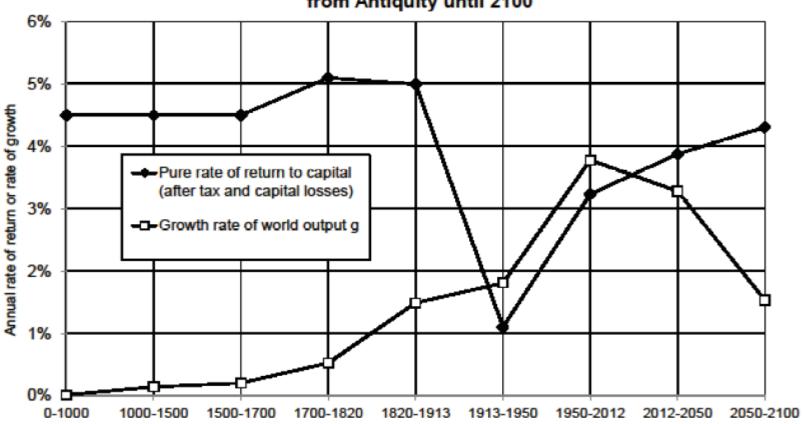


The rate of return to capital (pre-tax) has always been higher than the world growth rate, but the gap was reduced during the 20th century, and might widen again in the 21st century.

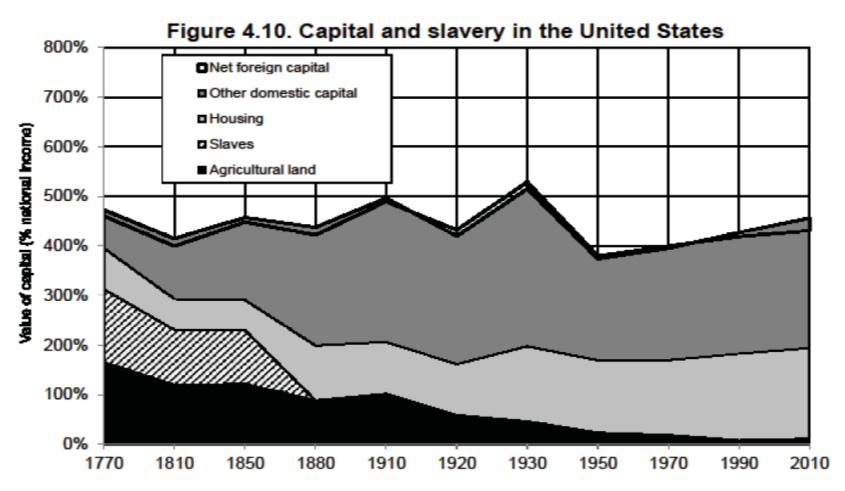
Rate of return to capital declines due to destruction caused by the WWs

Slaves were important as capital in America in 19th century



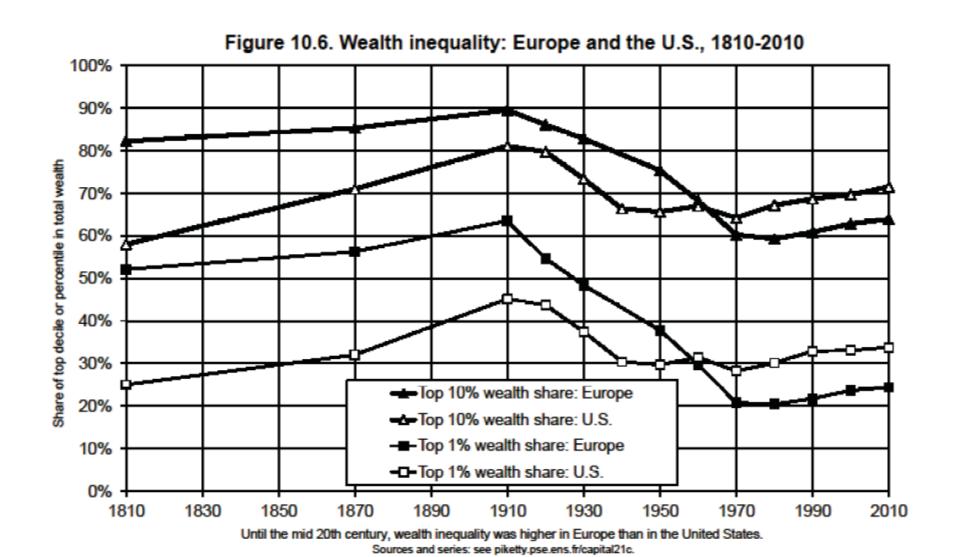
The market value of slaves was about 1,5 years of U.S. national income around 1770 (as mush as land). Sources and series: see piketty.pse.ens.fr/capital21c.

Conclusions

- The history of income and wealth inequality is always political, chaotic and unpredictable; it involves national identities and sharp reversals; nobody can predict the reversals of the future
- Marx: with g=0, $\beta \uparrow \infty$, r $\rightarrow 0$: revolution, war
- My conclusions are less apocalyptic: with g>0, at least we have a steady-state β=s/g
- But with g>0 & small, this steady-state can be rather gloomy: it can involve a very large capital-income ratio β and capital share α , as well as extreme wealth concentration due to high r-g
- This has nothing to do with a market imperfection: the more perfect the capital market, the higher r-g
- The ideal solution: progressive wealth tax at the global scale, based upon automatic exchange of bank information
- Other solutions involve authoritarian political & capital controls (China, Russia..), or perpetual population growth (US), or inflation, or some mixture of all
